



Information on processing of personal data

Who is who?

The controller of your personal data, i.e. the entity responsible for the lawful use of this data, is **Związek Harcerstwa Polskiego (The Polish Scouting and Guiding Association)**, an association with its registered office in Warsaw, Marii Konopnickiej 6 (hereinafter referred to as "ZHP").

How to contact us?

The Ensign is committed to ensuring that personal data is processed in a manner that ensures lawfulness and security. To this end, we have appointed a Data Protection Officer whom you may contact directly:

Why do we need your personal data?

Your personal data will be processed in order to:

- Compile and disseminate photographic documentation on the ZHP's website and social media (Article 6(1)(b) of the RODO/GDRP General Data Protection Regulation). Data will be stored until you withdraw your consent.
- Accept your application as a patrol leader participating in the Wędrownicza Watra 2025 and to organise and conduct the event (Article 6(1)(b) of the RODO/GDRP General Data Protection Regulation). We shall store your data for the duration of the cooperation.
- Make contact with your patrol in relation to cooperation within the framework of the project (Article 6(1)(b) of the RODO/GDRP General Data Protection Regulation). We shall store your data for the duration of the cooperation.

To whom do we disclose your personal data?

Your personal data will be shared on the basis of the law and on the basis of the concluded agreements on entrustment of personal data processing, including to ICT service providers, Facebook, Instagram. Your data will be disclosed to members of the ZHP patrol who will be paired with your group.

What rights do you have?

At any moment, you have the right to:

- Withdraw your consent to the use of your personal data; the withdrawal of the consent will have no negative consequences; the withdrawal of consent does not affect the lawfulness of personal data use based on the consent before its withdrawal.
- Object to the use of your personal data based on our legitimate interest; if you object, we will consider whether in view of your particular situation the protection of your interests, rights and freedoms overrides the interest we wish to accomplish by using your personal data. If your objection is deemed legitimate and there is no other legal basis for the use of the given data, they will be erased.

Moreover, you have the right to request:

 Access to your personal data, confirmation whether we use your personal data, a copy of them and information, among other things of: the purposes for which they are used, categories of personal data, categories of recipients to which the personal data have been or will be disclosed, the intended retention period of the personal data as well as the source from which we obtained them.





- To have your personal data rectified if they are incomplete, incorrect or out-of-date.
- To have all or some of your personal data erased if they are no longer necessary for the purposes for which they were collected or for which they were used, or if they were used unlawfully from the beginning, in particular if you have withdrawn your consent for the use of your personal data or if you have raised a legitimate objection to the use of your personal data.
- Restriction of the use of your personal data, i.e. to request that we cease to use them (however, without ceasing to retain your personal data) in the cases where:
 - you question the correctness of the personal data,
 - you question the lawfulness of our use of the personal data,
 - we no longer need those data, but you need them to establish, assert or defend legal claims,
 - you have objected to the use of the personal data.
- To receive your personal data in a structured, commonly used and machine-readable format and to transmit those data to another data controller of your choice; you also have the right to request that we send the personal data directly to such a controller if it is technically feasible; this only applies to personal data processed by automated means based on consent or agreement.

You have the right to file a complaint regarding the use of your data with the President of the Personal Data Protection Office: ul. Stawki 2, 00-193 Warsaw. The complaint may be filed in electronic form, in writing, or verbally for the record in the headquarters of the President of the Office.

Consent for personal data use

I hereby consent to the use of my personal data, including the physical likeness, by the Polish Scouting and Guiding Association for the purposes of the participation in the Wędrownicza Watra 2025. The use of my personal data to which I consent will include the reproduction of the physical likeness recorded on images, including moving images, made during and in connection with their participation in the Wędrownicza Watra 2025, in the following manner:

- multiplication of the images' copies by means of any technique, including printing, reprographic copying and digital photography,
- gratuitous marketing of the images' copies,
- public distribution of the images so that anyone may access them in any place and time, in particular on websites, social media, mobile applications,
- reproduction of the images by means of e-mail,
- public display and presentation of the images or presenting them to the general public.
